April 2024 REAIE Study Group Terms and Conditions

The cost of the 2024 April Study Group is:

\$3750.00AUD - Early Bird Member Price valid from 13 September to 1 October 2023

Deposit required \$750AUD per person (Member price is only valid until 1 October 2023)
\$3950.00AUD - Regular Price valid from 2 October 2023

Deposit required \$950AUD per person

This cost includes visits to schools, local bus travel to schools and other venues, meetings, presentations, morning and afternoon teas, lunch, interpreters, insurance against damage to schools, and printed materials. Also included are pre-tour readings, meetings, as well as costs associated with providing two Australian Study Group Leaders, and general administration costs of the Study Group. Finally, delegates are required to pay a 20% tax to the Italian Government for professional learning undertaken in Italy. The tax was introduced in 2009 and is included in the fee.

N.B The fee is an all-inclusive cost to all participants and cannot be altered for not participating in some of the components, e.g. land transportation, etc.

N.B The fee does not include accommodation, airfares, insurance, transfers or other associated costs.

The demand for places is high, and places will be allocated on receipt of your registration form and deposit on a <u>first come, first served basis</u>. No exceptions are possible. Registrations will <u>close on 27 November 2023</u>, or as soon as all places are filled. REAIE will require a minimum number of delegates for the Study Group to proceed.

REAIE has signed a contract with Reggio Children in Reggio Emilia for a specific number of REAIE Study Group delegates. REAIE is required to pay a non-refundable deposit to Reggio Children for the total number of delegates.

- Delegates who cancel their registration before <u>27 November 2023</u> will incur an administration fee of \$100AUD.
- Registration cancellations that occur <u>between and inclusive of 28 November 2023 and 26 February 2024</u> will incur a loss of the full deposit paid.
- Final balance payment is due by <u>26 February 2024</u>.

Delegates wishing to pay in instalments need to contact REAIE when submitting their registration, payment in full will be required by 26 February 2024.

<u>Cancellation after 26 February 2024</u> will incur a total loss of fee of the full fee where the place is unable to be filled by another delegate. If the place is filled, the loss incurred will be the deposit paid.

Participant Obligations:

Reggio Children and REAIE require all delegates to have taken out:

- an individual insurance policy for accidents of any type in which they may occur during the Study Group.
 Reggio Children will provide delegates insurance for damages caused to people or things inside the municipal institutions;
- an individual insurance policy covering medical/hospital and/or hospitalisation expenses, as well as travel, board and accommodation for any additional day spent in Italy, in the event of any general health problems and/or any health emergencies that may arise in situ.

The following cancellation conditions apply:

- Reggio Children and REAIE reserves the right to cancel the Study Group or the in-person professional
 development in Reggio Emilia with at least five days' notice prior to the start date of the professional
 development activity, if the minimum number of delegates required for the organisation of the service is not
 reached. In this case Reggio Children and REAIE reserves the right to reschedule the service, without giving
 rise to any reimbursement.
- 2. Reggio Children and REAIE reserves the right to modify the programme due to organisational needs or exceptional circumstances. Changes may be made to dates, times, activities on the day, programme and trainers. These types of organisational changes do not entitle the delegate to any reimbursement.
- 3. The professional development activity may be cancelled if the health situation in Italy, or in the foreign country of origin of the purchasing delegate(s), requires it due to government measures or regional provisions. To this end, Reggio Children will be responsible for promptly informing all participants of such a possibility, proposing an alternative date to be agreed upon with the delegate(s) within one year of the date initially arranged.
- 4. Reggio Children and REAIE are not responsible for further costs deriving from any changes or cancellations of the programme in the above-mentioned cases or from any quarantine that oblige delegates to extend their stay in situ. Therefore, the delegate shall bear the cost of taking out an appropriate travel insurance policy in the event of cancellation and/or modification of the travel, board and accommodation

Reggio Children Privacy Request:

Delegates must not photograph and/or videotape inside the infant-toddler centres and preschools of Reggio Emilia. Additionally, photos or videos must not be taken of the presentations as well as of the panels and videos inside the Exhibition area and the Atelier at the International Centre Loris Malaguzzi.

Contingency Payment

REAIE has calculated the fee to Reggio Children as close to the current exchange rate as possible to keep costs down for participants. If there is a fall in the exchange rate between now and when the fee to Reggio Children is paid, a small additional fee (no more than \$250AUD) may have to be charged. REAIE is not in a financial position to absorb the additional costs of the Study Group if there is a dramatic fall in the currency exchange.
